Home Hot Yoga (HHY) agrees to provide a temporary, short term service for the children of our students while such students are on our premises attending yoga class. Services are limited to a maximum of 2 hours per day and available only during the posted participating class times. 24 hours notice via email is required for booking and space is limited. In exchange for this service, the student agrees to pay the advertised rate to HHY, along with any incurred fees (i.e. late cancellation fee.) By signing this agreement, the student states that he/she is the parent or legal guardian of the child, the child is within the age of 4 months to 12 years, and the child does not require a level of specialized care or attention.

Additional Agreements:

- HHY reserves the right to require written proof that the student is the parent or legal guardian of the child.
- HHY adheres to a Sick Child Admittance Policy (no child who has a fever, cough, or is vomiting will be allowed to stay).
- Student has read, understands and agrees to follow all HHY childcare rules and regulations.
- Student must present picture ID to a HHY childcare attendant upon checking-in and checking-out their child or prior to entering childcare room at any other time.
- HHY enforces a behavioral guideline for the protection of the children and staff. The behavioral guideline covers all instances of biting, hitting, pinching, fighting or other acts that may cause physical or emotional harm to other children or staff members. Depending on the severity of the situation, HHY reserves the right to deny further admittance to the childcare room at the sole discretion of the childcare attendants.
- Food is strictly forbidden in the childcare room. Please feed your child before arrival. A drink in a spill-proof cup or bottle with the child's name on it is allowed.
- No shoes are allowed beyond the front entryway. Socks are optional.
- Toilet-independent children should use the restroom prior to check-in. Children who wear diapers should have a fresh diaper on at time of check-in.
- HHY staff do not change diapers or help children use the toilet.
- In the event your child needs a diaper change, help at the toilet or becomes inconsolable for any reason, you will be asked to come out of class and care for them. You are welcome to return to class afterward.
- Student agrees to notify HHY babysitting attendants of any changes or updates that should be made to child information form
- HHY will make every reasonable effort to accommodate the needs of all children; however HHY is not properly staffed or equipped to provide babysitting services to any child requiring constant individual or specialized care.
- HHY's emergency protocol will be followed in case of a medical emergency. By signing, student gives consent that the minor child may receive emergency medical treatment deemed advisable by emergency service personnel and agrees to pay for any medical expenses incurred by the minor.
- HHY has the right to refuse service to anyone for any reason and the right to change or modify any of its policies and procedures at any time.
- Student agrees to release, hold harmless, and indemnify HHY and its employees, volunteers, owners and the owners of the building for any claims made by the minor, or brought about on behalf of the minor.

I have read and agree to abide by the HHY Childcare Agreement printed above and the guidelines for childcare as explained to me and posted in the studio and on the HHY website. If applicable, I further agree and authorize those individuals, identified on Lines B and C as persons authorized to check-in and check-out the child in my absence. By way of the signature, those individuals separately agree to the terms of this Agreement.
